We are excited to welcome you back to campus for face-to-face classes beginning August 24, 2020.

Please be aware that as the University phases in hands-on technical courses in the College of Applied Technologies, students who only have 1 or 2 technical courses left in their program will be prioritized over continuing students. Due to Health Department regulations, classes will be offered at a reduced capacity and therefore students' ability to choose their time preference will be temporarily suspended. In order to offer needed classes to the most number of students in the shortest amount of time, it means your desired class will be offered in one of the following time frames:

- Mornings (Monday – Thursday 7:30am – 12:30pm)
- Afternoons (Monday – Thursday 1:00pm – 6:00pm)
- Evenings (Monday-Thursday 6:30pm -11:30pm)
- Early Mornings (Tuesday-Thursday 12:00am – 6:30am)

After accommodating the graduating students, continuing students will be scheduled followed by returning students and then new incoming students will be placed into classes.

Over the following weeks you will be receiving communications to your UNOH email address about the upcoming August Session:

- UNOH Advising started scheduling you for needed courses the week of June 29, 2020
- August Session schedules will be posted to your MyUNOH Portal by July 24, 2020
- Bills for the August Session will be posted after July 24, 2020. Payment must be complete prior to your first day of classes.
 - If you plan to use financial aid for the August Session the 2020-2021 renewal FAFSA needs to be completed at <https://studentaid.gov/apply-for-aid/fafsa>. Review your financial aid status on the Financial Aid Dashboard at your MyUNOH portal. If you have financial aid questions, please contact financialaid@unoh.edu
- Before you can be scheduled for classes and/or placed in on-campus housing, you must have financial aid in place or a payment in the amount of \$1,300 towards the August session.
- Once your schedule is posted, make arrangements to purchase any needed course materials prior to August 24, 2020.
 - Students will be required to wear a face mask while inside campus buildings. During certain shop work, a face shield will also be required. UNOH will supply each student with 1 reusable, washable face mask but it is advised that students bring more with them to wear throughout the week. A variety of face shield options will be available for purchase from Barnes & Noble starting at \$5.98 each.
- If you require on-campus housing, you will receive a housing assignment no later than July 27.

- You will be notified of a specific window of time that you can return to on-campus housing. The University is assigning certain windows of time to allow for a safe and responsible move in process while limiting the physical interaction of students and families moving into campus housing.
