Due to Health Department regulations, classes will be offered at a reduced capacity and therefore students should expect classes to be offered in extended time frames and additional delivery methods (including the potential for continuing online courses) for Fall Quarter.

Over the following weeks you will be receiving communications to your UNOH email address about the upcoming Fall Quarter:

- Registration for Fall Quarter begins on **July 17, 2020**
 - Classes will be offered Monday through Friday, including M/W, T/Th, and M/W/F options. Due to capacity regulations, you may have to schedule for classes throughout the day into the early evening. There may also be classes that are only offered in an online environment.
- Please check Student Planning to make sure you are registering for classes that are required as part of your degree program.
- Bills for Fall Quarter will be posted after **August 14, 2020**. Financial aid must be in place or payment must be arranged prior to your first day of classes.
 - If you plan to use financial aid for the Fall Quarter the 2020-2021 renewal FAFSA needs to be completed at <https://studentaid.gov/apply-for-aid/fafsa>. Review your financial aid status on the Financial Aid Dashboard at your MyUNOH portal. If you have financial aid questions, please contact financialaid@unoh.edu
- Once you have registered for your classes, make arrangements to purchase any needed course materials prior to **September 14, 2020**.
 - Students will be required to wear a face mask while inside campus buildings. UNOH will supply each student with 1 reusable, washable face mask but it is advised that students bring more with them to campus to wear throughout the week.
- If you require on-campus housing, you will receive a housing assignment no later than **August 24, 2020**.
 - You will be notified of a specific window of time that you can return to on-campus housing. The University is assigning certain windows of time to allow for a safe and responsible move-in process while limiting the physical interaction of students and families moving into campus housing.
